

ROADMAP TOWARDS THE ESTABLISHMENT OF FABs


- Submitted by the Commission -

FABs Objective

Optimised service provision, interoperability, civil-military cooperation, performance scheme, network management functions, etc.

176/2011	→ Member States jointly provide a set of information and documents to interested parties the latest by 24 June 2012 .
550/2004	→ deadline on 4 December 2012 at the latest for FAB implementation

Establishment of FAB

Step 1 – Provision of information

By **June 24th 2012** at the latest
(the earlier the better),

FAB Members States provide
jointly the documentation in one
consolidated package to the
European Commission in
electronic form;



Establishment of FAB

Step 1 – Provision of information

Not only the **FAB Safety Case**

But also:

- Optimum use of airspace,
- Constituency with the European Route Network;
- Cost-benefit analyses;
- EU-wide performance targets
- Etc ...

Establishment of FAB

Step 2 – Dispatch of information

Within **one week after submission** by FAB Member States, i.e. on 2 July 2012 at the latest;

EC to inform the interested parties via emails and place the documentation package **on a public website** together with a **Comment Response Document** that follows the structure of the Annex for observations



Establishment of FAB

Step 3 – Observations



Within two months, Interested Parties Submit their observations to the Commission in a CRD.

At expiration of the 2 months period EC consolidates and transfers the submitted observations (incl. its own) in the CRD to the FAB Member States

Within a month after the end of the observations period the FAB Member States provide answers to the observations


NB: EC will take those answers into account in its formal assessment

Establishment of FAB

Step 4 – Formal Estbl. & EC Assessment

Member States notify European Commission of the State agreements.

European Commission makes **formal assessment** and reports to the SSC in the second half of 2013.



Establishment of FAB

Step 4 – Formal Estbl. & EC Assessment

EC to assess against the **9 FAB requirements** (Article 9a(2),
Regulation (EC) 550/2004)

but **also** on overall FAB objectives and other FAB-related
requirements;

In the event of **non-compliance** the Commission will engage the
relevant Members States in a dialogue as soon as practicable;

The Commission may **accept provisionally** FAB establishment
on conditions which need to be fulfilled within an agreed
timeframe.

The Road to June 24th 2012

What about submitting prior to the date?

Sept.2nd – Dec.4th = 3 months

Would observations to be **duly taken into account** and implemented?

FABs need time to **analyse** the comments, **identify** problems and **remedial** actions and **implement** them

Each **MS** will have to provide observations to 8 FABs;

By delivering the information as soon as possible MS might be in a **better position to ensure the compliance** with the requirements and positive formal assessment.
