



eTOKAI capabilities



- Organisation Management - Units configurations, users, investigators, email distribution lists
 - Users, Units, Regions, Organisation
 - Distribution lists

eTOKAI capabilities cont'd



- Occurrences Notification Forms, flows etc
 - Building Form
 - Import/Export of Forms
 - Flows
- Data Gathering
 - Forms, flows etc
 - Import from Notification and linkage
 - Building Forms
 - Walk through Taxonomy
 - Data Gathering Forms Import/Export
 - Attachments (of any kind)



eTOKAI capabilities cont'd



- Risk Analysis Tool (RAT) integration
- Integration with other tools (e.g. bi-directional with Data Gathering)
- HERA (Human Error in ATM) tool
 - At the level of Working Position
 - Integrated with other tools (bi-directional with Data Gathering and RAT)
- Safety Recommendations section
- Statistical Analysis
 - Combination of stats with RAT statistical analysis
 - Transferring data to Excel
 - Transfer file templates
- Annual Summary Template (AST)
- ECCAIRS converter
- Report Builder
 - building Corporate personalised reports (any kind of reports)



eTOKAI capabilities cont'd



- Custom organization workflows
- Configurable time based alert system
- Real-time notification system
- Re-engineered user management system
- RAT matrix statistics drilldown capability
- Audit & Trace module
- Query Systems (redesigned as we present)

What do you need to do (with our support) to deploy eTOKAI



- Choose server (EUROCONTROL NM or internal in your ANSP/FAB)
- Review forms and taxonomy
- Build forms and update taxonomy
- Build the SMS flow in the tools
- Set-up the units, regions, organisations, staff allocation and rights, distribution lists (all administration of the tool)
- Train the administrators
- Train the investigators
- Allow period for testing and feed-back
- Go live
- (mapping old taxonomy/database to new taxonomy to import your history)
