An ES² workshop was held in Sarajevo in May 2011. The purpose of this part workshop was to harmonize the implementation of FAB, taking into account the FAB-IR the European Commission adopted by the end of 2010, the performance plan as required from ANSPs and the Network Manager through the SES Performance Scheme EC Regulation (691/2010) for the first reference period RP1.

In light of the forthcoming second reference period RP2 that is driven by the SES Performance Scheme EC Regulation (390/2013), adopted and published by the Commission in May. The upcoming ES2-WS01-14 aims to harmonize the implementation of the EC Regulation (390/2013) and subsequently to address the follow-up of the FAB deployments by ANSPs.

Through the EC, the EASA and PRB, and the role of the Network Manager during the RP1, the workshop will be the opportunity to review the RP1 achievement, to assess the forthcoming RP2 and the role of the Network Manager in support of the FAB deployments by ANSPs.

Consequently, the workshop will give an opportunity to see how the FABs have built and are monitoring their safety Assessments, how they are implementing their SMS roadmaps and how they are preparing for the future challenges imposed by the forthcoming RP2. Last but not least the event is looking to share the knowledge amongst the experts on what is planned in the second reference period for Safety KPIs within each FAB.

Each FAB has a number of best practices and the workshop will allow sharing experiences to increase the SMS maturity and effectiveness. While acknowledging that one size does not fit all, the NM ESP+ programme is of the view that sharing knowledge amongst the ANSP is beneficial in improving the individual approaches and is a road for excellence.

The seminar is targeted to the safety, operational and engineering experts as well as managers of ANSPs involved in FAB developments. The NSA focal points, dealing with NSA agreements and NSA safety oversight of FABs, are welcomed at the FAB ANSPs discretion.
